## Volunteer release and waiver of liability

This release and waiver of liability executed on \_\_\_\_\_ (date) by \_\_\_\_\_ (volunteer) releases Saco River Wildlife Center (SRWC), a nonprofit corporation organized and existing under the laws of the State of Maine, and each of its directors, officers, employees and agents. The volunteer desires to provide volunteer services for the nonprofit and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of the relationship with Saco River Wildlife Center is limited to a volunteer position and that no compensation is expected in return for services provided by the volunteer. SRWC will not provide any benefits traditionally associated with employment and the volunteer is responsible for their own insurance coverage in the event of personal injury or illness as a result of volunteering with SRWC

1. Waiver and release: I, the volunteer, release and forever discharge and hold harmless SRWC and its successors and assigns from any liability, claims and demands of any nature, either on law or in equity, which may arise or may hereafter arise from services I provide to SRWC. I understand and acknowledge that this release discharges SRWC from any liability or claim that I have against SRWC with respect to bodily injury, personal injury, illness, death or property damage that may result from services I provide to SRWC or occurring while I am volunteer services.
2. Insurance: I understand that SRWC does not hold any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of SRWC beyond what may be offered freely by SRWC in the event of injury or medical expenses incurred by me.
3. Medical treatment: I hereby release and forever discharge SRWC from any claim whatsoever which arises or may hereafter arise on account of any first aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with SRWC.
4. Assumption of risk: I understand that the services I provide to SRWC may include activities that are hazardous to me including, but not limited, to inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release SRWC from all liability.
5. Photographic release: I grant and convey to SRWC all right, title and interest in any and all photographs, images, video or audio recordings of me or my likeness or voice made by SRWC in connection with my providing volunteer services to SRWC.
6. Other: As a volunteer I expressly agree that this release is intended to be broad and inclusive as permitted by the State of Maine and that this release shall be governed by and interpreted in accordance with the laws of the State of Maine. I agree that in the event that any clause or provision within this release is deemed invalid, the enforceability of the remaining provisions of this release shall not be affected.
